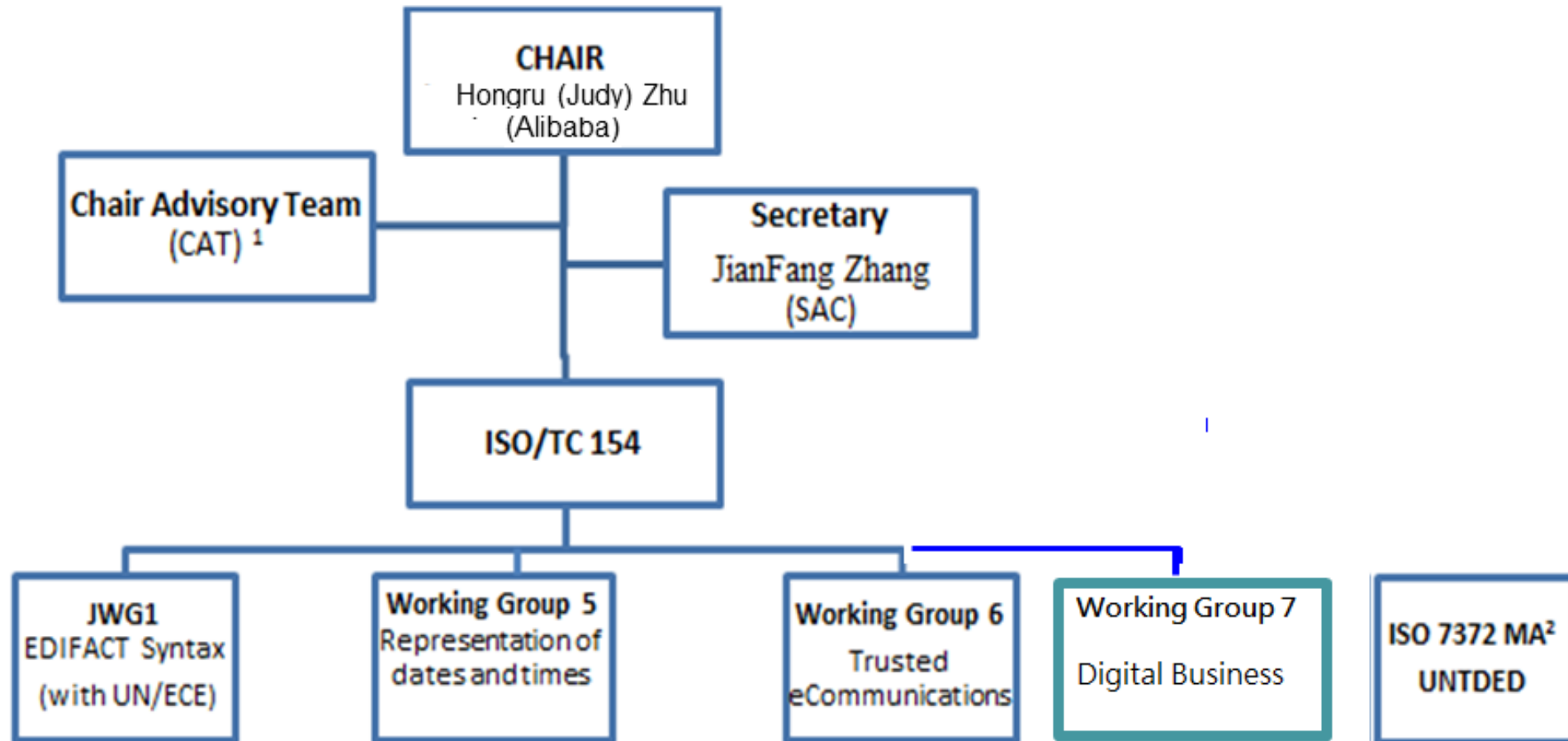

WG5 (Representation of Date and Time)

- **ISO/DIS 8601-1** (Basic rules) & **ISO/DIS 8601-2** (Extensions) : Has now completed DIS vote, Currently is processing comments and then continue with FDIS vote.
- WG5 has a new convener by the United States Mr. Ray Denenberg. (Mr. Klaus health reasons to resigned his job)



WG6 (Trusted eCommunication)

1. ISO 14533-3 : has been submitted to ISO / CS to be published.
2. ISO 14533-4 : is still the WD stage.
3. ISO 19626-1 : has completed CD voting and Currently is processing comments.
4. ISO 19626-2 : plans draft standards to submit in October to discuss and vote.
5. ISO 20415 : is on CD vote.



WG7(Digital Business)

- ISO / TS 21981 : The Business Semantics Thesaurus (BST) dictionary is still in the WD stage.(the project leader will change to Mr. Anders Grangard (GS1))
- ISO 22468 : Value Stream Management (VSM) currently in the WD stage. The preparatory stage will be ended in Q I/2018.
- WG7 has a new convener by the Luxembourg Mr. Peter Plaoer. (Mr. Klaus health reasons to resigned his job)



Other Item

1. OAGi (Liaison Organization) is still preparing the document formatted for "**enterprise specification model specification**" standard project.
2. A new informal working group "**Logistics data elements and process** " is under discussion. May soon have a formal working group in the future.
3. The **International port Community Systems Association (IPCSA)** is applying to become a liaison organization for ISO / TC 154.
4. UN/CEFACT A-liaison application.
(If UN/CEFACT becomes the A-liaison member someday, Anders and Sue may contact with UN/CEFACT to appoint the liaison officer to support the further work in TC154.)
